This Memorandum of Understanding (hereinafter referred to as "MOU") made on this 25th July 2022 by and between LBHSST's Institute of Computer Application S.No.341, Next To New English School, Govt. Colony, Bandra East, Near Kherwadi Police Station, Mumbai, Maharashtra 400051 and Swachh Sustainable Solutions Pvt. Ltd., having its registered office at A- 03, Rituraj IA[apartment, Opp SNDT College, Juhu tara road, Santacruz west, Mumbai-400049(hereinafter referred to as the "ReCircle ").

"LBHSST's Institute of Computer Application." and "ReCircle" shall hereinafter be individually referred to as "Party" and collectively referred to herein as "Parties".

WHEREAS:

- A. ReCircle is a Resource recovery enterprise that provides pickup and drop of service to offices, institutions, households, schools and other consumers to dispose of their recyclable waste (RrCircle).
- B. LBHSST's Institute of Computer Application with its aim for bringing sustainable development has approached ReCircle to provide recycling solutions as per the terms mentioned in the MOU below.
- C. The Parties hereby agree that this MOU is in supersession of all arrangements, oral or in writing that may have been executed between the parties.

NOW, THEREFORE, in consideration of the mutual covenants and MOUs contained herein, the adequacy and sufficiency of which are expressly acknowledged by the Parties hereto, the Parties agree as follows:

THE MEMORANDUM OF UNDERSTANDING BETWEEN THE TWO PARTIES IS SET OUT BELOW-

1. The MOU shall commence from July 2022 and shall be valid up to July 2023.
2. ReCircle shall arrange to collect all the Dry Recyclable Waste from the LBHSST's Institute of Computer Application on request.
3. ReCircle shall collect all the Recyclable Waste from the LBHSST's Institute of Computer Application as agreed herein between mutually accepted date & time.
4. The Recyclable Waste collected from the LBHSST's Institute of Computer Application may contain such information of the Company which shall be treated as confidential by us. ReCircle assures and agrees that all the Recyclable Scrap collected from Dr. Baliram Hiray College shall be used only for Recycling the Waste and for no other purpose.

5. ReCircle agrees to indemnify and keep **LBHSST's Institute of Computer Application** indemnified against any misuse of the Recyclable Scrap collected from **LBHSST's Institute of Computer Application**.
6. ReCircle's Recyclable Scrap collection representative shall at all times carry a valid identity card at the time of visiting **LBHSST's Institute of Computer Application** for the collection of recyclable scrap.
7. **LBHSST's Institute of Computer Application** has chosen to go for the "Recycle for Certificate" option, where ReCircle will provide a certificate of safe disposal to **LBHSST's Institute of Computer Application on a half** yearly basis. It will be a cumulative certificate for material collected for every month.
8. ReCircle shall collect the Recyclable Scrap from a designated place at all times & will have to ensure relevant permissions are in place for taking the material out from the mall/store.
9. A list of items ReCircle will collect along with description is mentioned in **Annexure 1**.
10. **LBHSST's Institute of Computer Application** will provide a point of contact from each team to coordinate the pickups on a regular basis. The point of contact will be present during the pickup to verify the quantity & quality of material that has been collected.
11. This MOU shall not be construed to constitute, create, give effect to or otherwise imply any joint venture, partnership or any formal business relationship between us.
12. This MOU shall be valid for a period of one **(1) year** commencing from the Effective Date unless terminated by either party by giving a prior notice of one (1) month. .
13. The courts of Mumbai having jurisdiction, will, to the exclusion of any other, try and adjudicate any or all matters concerning or arising from this MOU.
14. The MOU shall not grant any right of any nature over the trademarks/copyrights or any other intellectual property of **LBHSST's Institute of Computer Application**, whether registered or not in favor of ReCircle and does not grant any license to ReCircle to claim usage except for using the logo of **LBHSST's Institute of Computer Application**, on the website of ReCircle and social media platform to the extent of showcasing the association of work between, **LBHSST's Institute of Computer Application**, and ReCircle and not for any reason whatsoever.
15. This MOU is made in two originals, copy for each party. Both the parties hereby agree to and accept the terms and conditions of the MOU and affix their sign and seal below.
